- b. Question was there enough Referees in Travel? Answer = Yes, MID NJ Assigns Referees, we can assign Referees.
  - c. Question can fields be used during winter for practice? Answer = Yes, just not game fields.
  - d. Question how do we recruit? Answer = We send home over 5600 flyers through Piscataway Public and Private Schools grades K through 5. We have an email list of over 600 that we stay in touch with regularly. We had an 150% increase in Travel since the Spring Season. We also launched a Facebook Page. Mike DeSordi will check with the township on if we can advertise on the lighted portable signs when we have open enrolment and tryouts.

  - f. Tom Roberts Travel VP – Only one game did not get played this past fall. \$300 in fines received in red cards from coaches, that were paid by the coaches not the club. Tom asked coaches of 1<sup>st</sup> games to make sure they get started on time or the whole day falls behind schedule.
  - g. Jeff Sundelof Instructional VP. Jeff was at New Market this past fall all season and thought the season went very well. Discussion ensued on combining U8 and U9 for the Fall Season.
