Registration Refund Raffle

**Official Rules:**

**1.** All teams must be registered, paid in full and accepted for the 2011 Piscataway Soccer Club Fall Classic Tournament by midnight **Friday August 5, 2011** will be automatically entered into the raffle. The winner will be selected by random drawing.

**2. Eligibility:** This drawing is open only to accepted registrations with complete registration information and payment in full. Piscataway Soccer Club teams or teams coached and/or managed by Piscataway Soccer Club board members are ineligible.

Submit your payment as directed (payment must be received by **August 5, 2011**). No exceptions to this deadline. The Sponsor (the Piscataway Soccer Club Fall Classic Tournament) of the raffle does, however, reserve the right to extend the "registered by, paid by and accepted by" end date to qualify for the drawing.

**4. Prize Awarded:** One team will receive a full refund for their registration to the 2011 Piscataway Soccer Club Fall Classic Tournament. Payment will be made by check to the original payee (i.e. Club or Coach). The odds of winning may not be known at the time of your registration but will depend on the number of teams registered, paid and accepted by the drawing deadline.

**5. Identification and Notification of Drawing Winner:** The Piscataway Soccer Club will award the refund upon winner verification and approval. Winner will be selected no later than August 22, 2011.

Drawing winner will receive notification by phone call and/or e-mail to the drawn team's registered contact and will have five (5) business days from notification date to accept the prize or will be disqualified and an alternate winner will be drawn.

If the drawn winner has not complied with the Official Rules, cannot be contacted, is ineligible, the notification of refund is returned as undeliverable, or does not respond within the specified time period, an alternate winner will be drawn.
